COMPLAINT

The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s). The complainant states that the following facts establish PROBABLE CAUSE:

Your complainant, Detective Cory Cardenas, is a detective with the Bloomington Police Department and has been employed there as a peace officer for more than sixteen years. Complainant has been investigating allegations that William Francis Carroll, date of birth 7/18/47 and CYNTHIA ANN RUDIGER, date of birth 8/18/44, Defendant herein, financially exploited and swindled money from their former employer, Portable Sanitation Association International (PSAI). Complainant learned the facts set forth below during meetings and conversations with PSAI representatives, employees and others, including William Francis Carroll, Defendant Rudiger and other witnesses. Complainant also reviewed numerous documents obtained in the investigation, including emails, spreadsheets, bank records, and other documents.

I. General Background of William Francis Carroll, Defendant RUDIGER and PSAI

Portable Sanitation Association International (PSAI) is a 501(c)(6) non-profit trade organization of portable sanitation companies. In 1990, PSAI hired William Carroll as Executive Director of the company. Carroll's wife, Millicent Carroll, was hired by PSAI later on that year as an independent contractor-administrative assistant. Defendant Rudiger was hired as an employee for PSAI by William Carroll in 2001 as a bookkeeper for PSAI. William Carroll was entrusted with all of the financial affairs of the company, including directing the preparation of financial records and payroll by Defendant Rudiger. In the fall of 2011, another employee who had been terminated by William Carroll, implied that there was corruption in the business. A payroll audit of PSAI revealed that over \$350,000 had been misappropriated from PSAI. Representatives of PSAI then made a report to the Bloomington

Police Department and this investigation was then commenced. William Carroll resigned and the employment of Defendant Rudiger and Millicent Carroll were terminated.

II. William Francis Carroll and Cynthia Ann Rudiger's Scheme to Defraud and Steal from PSAI

Complainant met with representatives of PSAI at the Bloomington Police Department. PSAI officials provided documentation of financial transactions, usually in the form of "advance" that had been conducted by William Carroll that purported to be on behalf of PSAI, but were actually for the benefit of William Carroll. Those transactions were recorded with codes by the bookkeeper, Defendant Rudiger so that they appeared to be business related expenses or transactions on behalf of PSAI. As a result of the falsification of financial records by Defendant Rudiger, William Carroll was able to conceal the theft of hundreds of thousands of dollars over multiple years. In addition, William Carroll also authorized cash payments to Defendant Rudiger and concealed the thefts by directing Defendant to falsely code the cash payments, usually as "Insurance" or "Payroll Adjustment." Complainant examined bank statements and other financial records in connection with PSAI and learned that funds had been stolen from PSAI by William Carroll by ATM cash withdrawals, debit card withdrawals, bank withdrawals or credit card advances, and were then "coded" by Defendant as a legitimate business transaction. An examination of the records documenting the monies embezzled by William Carroll during 2011 reveals that over \$30,000 was taken in the form of cash and over \$32,000 was obtained by transactions at or immediately outside of a casino.

III. DEFENDANT RUDIGER'S Statement

On August 14, 2012, Defendant Rudiger voluntarily appeared at the Bloomington Police Department with her attorney. After being informed of the nature of the investigation, Defendant said that she wanted to consult with her attorney before deciding whether or not to give a statement.

On August 28, 2012, Defendant voluntarily returned to the police department, again accompanied by her attorney. Defendant told the officer that she was aware of the "cash advances" that Carroll was taking and coded those

transactions at his direction. Defendant claimed that she thought it was okay because Carroll was paying the money back. Defendant admitted that she was worried about Carroll's gambling problem, but did not think he was using company money.

Defendant was asked about the checks that she received coded under "Insurance." Defendant acknowledged receiving the checks but thought they were justified as she hadn't had an increase in salary. Defendant admitted that she did not report those checks as income on her taxes for 2009 through 2011. Defendant said that she did not believe that Millicent Carroll was aware of the extent of her husband's gambling problem. Defendant said that Millicent Carroll's responsibilities did not include any of the financial aspects of PSAI. Defendant said that she had no knowledge of and had not seen Millicent Carroll use company cards for anything other than legitimate business purposes.

IV. WILLIAM CARROLL's Statement

On August 27, 2012, William Carroll was interviewed at the Bloomington Police Department after he was advised of his rights pursuant to the *Miranda* decision. William Carroll waived his rights and agreed to speak to Complainant. Complainant informed William Carroll that he wanted to ask him questions about misappropriation of funds from PSAI for the years of 2009, 2010 and 2011. William Carroll admitted that he had taken cash "advances." When confronted about Defendant's knowledge of the number of cash advances that he was taking and doing so at casinos, William Carroll admitted that Defendant "knew his background." William Carroll said that he directed her to code the improper transactions so that they would appear legitimate to the accounting firm. William Carroll also admitted that he authorized cash payments to Defendant under the guise of reimbursing her costs for health insurance. William Carroll admitted that the payments were not reported as income to the IRS. William Carroll admitted that most of the cash that he took from PSAI was for gambling and alcohol. William Carroll also said that he also used his wife's company debit card and that she had nothing to do with using any credit/debit cards fraudulently at any time.

An examination of the records documenting the moneys embezzled by William Carroll and Defendant reveals that the sums received by Defendant for "Insurance" or "Insurance Adjustment" had no correlation to payroll dates or payroll deductions for payments for health insurance. Records also revealed that William Carroll had made some efforts to return some of the money, but the repayments were a fraction of the amounts stolen. PSAI representatives noticed that the thefts dropped dramatically when the fourth employee was fired and had made mention that there was corruption in the company.

V. MILLICENT CARROLL's Statement

On August 27, 2012, Millicent Carroll was interviewed at the Bloomington Police Department after being advised of her rights pursuant to the *Miranda* decision. Millicent Carroll waived her rights and agreed to talk to Complainant about the investigation. She acknowledged working at PSAI in Industry Regulatory Standards and said she had no knowledge of or participation in the financials of the company. She said that she had access to credit/debit cards as part of her employment, but denied ever using those cards for personal use, or at a casino. Millicent Carroll said that she knew that her husband liked to drink and gamble, but was unaware that he was using company cards or cash to fund his gambling and drinking. Millicent Carroll told Complainant that she had been at casinos with her husband but denied ever taking or using a company credit or debit card. She told Complainant that she thought her husband was using their money to gamble as they are completely broke and facing foreclosure on their home.
